7. PROCUREMENT AND MILEAGE RATES:

The PA bidding thresholds and the IRS mileage reimbursement rate for 2025 will be as follows:

- Under \$12,900; No formal bidding or written/telephonic quotations required
- \$12,900-\$23,800; Three written/telephonic quotations required
- Over \$23,800; Formal bidding is required
- 2025 standard mileage rate will be 70 cents per mile for business

Motion made by Shawn Wolfinger to accept the thresholds and mileage rate for 2025; second by Jeff Wilcox. All were in favor, motion passed.
